Important Pressurized Irrigation Information



Public Works will turn on the pressurized irrigation around April 15th (Can be up to two weeks before or after depending on weather).

It takes two to three days to fully charge the system. Please check your valves and make sure your system is ready to avoid flooding from possible broken pipes or taps that are turned on.

and large boxes. Do NOT take paint or liquids,
toxic materials/chemicals, household garbage,
freezers, refrigerators or tires.
