### Municipal Election Information

Santaquin City will be holding a Municipal Election November 2<sup>nd</sup>, 2021. At this time the Mayor's 4-year seat and two 4-year City Council seats will be vacant and up for election. If there are enough filings for candidacy, then a primary election will be held August 10<sup>th</sup>, 2021. **The filing period will be June 1st through June 7th, 2021**, during Santaquin City business hours as laid out in Utah State Code 20-A-9-203(3)(a). Those interested must file **in-person**, again in accordance with Utah State Code 20-A-9-203(3)(a), with the City Recorder during this time frame.

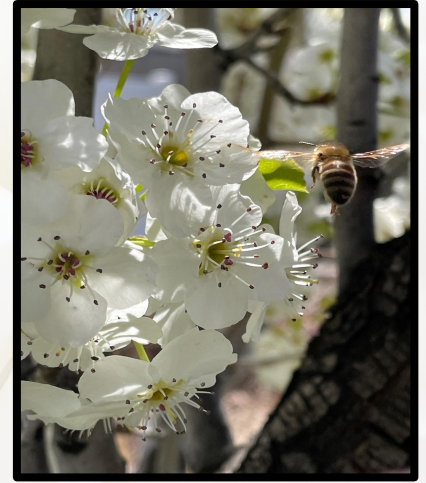

## Dear Santaquin Residents and Friends,

Our community has blossomed into a beautiful oasis with all the spring and summer flowers in full bloom. What a blessing to live in such a lovely area. But with the oncoming heat that summer brings, we are faced with drought conditions once again and we need to do our part in conserving water. Our governor has issued an executive order for watering restrictions on state facilities and has encouraged local governments to apply similar water restrictions on public landscaping. You will see many of these restrictions implemented on our city landscapes throughout the summer. He has also asked all residents of Utah to reduce water use with delayed irrigation to avoid evaporation, fix irrigation inefficiencies, follow the lawn watering guide at

<https://conservewater.utah.gov/guide.html>,

take shorter showers, install low-flow toilets, turn off water when not in use, convert landscaping to waterwise landscaping, and be an advocate of water efficiency. Because Santaquin captures and recycles all wastewater through the Santaquin Water Reclamation Facility, we typically do not need to implement yard watering restrictions; however, we will closely watch our water resources and notify you through this newsletter, by email, and on our website and social media if restrictions are put in place. By volunteering to implement water conservation practices right away to help avoid the need to mandate a restriction on water usage on our lawns and gardens.



On a different note, I recognize it has been a difficult 18 months for many residents due to the Covid-19 pandemic. Jobs have been lost and financial hardship has occurred for many. I was happy to learn, and now pass on to you, that the Federal Consolidated Appropriations Act of 2021 allows eligible households to receive a discount off the cost of broadband internet service, up to \$50 per month, during the emergency period relating to Covid-19. To learn if you qualify for this discount, visit [www.centracom.com](http://www.centracom.com). You may qualify if you meet any of the following: (1) Already qualify for the Lifeline program. (2) Household income is at or below 135% of the Federal Poverty Guidelines. (3) At least one member of the household receives benefits from one of the following federal assistance programs: Medicaid, SNAP, Supplemental SSI, Federal Public Housing Assistance, or Veterans and Survivors Pension Benefit. (4) Experienced a substantial loss of income since February 29, 2020 and can provide a layoff or furlough notice or application for unemployment benefits. (5) Received a Federal Pell Grant during the current award year. (6) Receive free or reduced school lunch. I encourage you to apply for this benefit if you feel you may qualify.

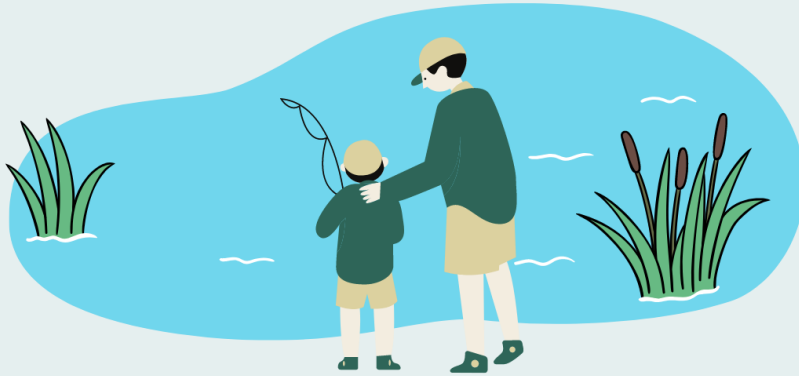
