Ordinance 5-03-2015

AN ORDINANCE AMENDING CERTAIN PORTIONS OF THE SANTAQUIN CITY CODE PERTAINING TO PERMITTED USES IN THE RC ZONE, PROVIDING FOR CODIFICATION, INCLUSION IN THE CODE, CORRECTION OF SCRIVENER'S ERRORS, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, the City Council has been given specific authority in Utah Code Annotated, Title 10, Chapter 9a. to adopt land use and subdivision ordinances to regulate the erection, construction, reconstruction, alteration, repair and uses of buildings and structures and the uses of land, which are reasonably and appropriately related to the objectives of providing for the public safety, health, morals, and welfare; and

WHEREAS, Santaquin City has adopted land use regulations in accordance with Utah State Code, Annotated 1953, as amended, Section 10-9a; and

WHEREAS, a request has been made to amend Santaquin City Code, Title 10 of the Revised Ordinances of Santaquin City (the Land Development Code) by amending Section 10-7I, RC Residential Commercial Zone, in order to consider allowing kennels in the RC Zone and to clarify the list of permitted uses within the same zone; and

WHEREAS, the Santaquin City Planning Commission discussed the proposal at a public meeting held on March 12, 2015 and conducted a public hearing on the amendment on April 9, 2015, after which they forwarded the amendment with a positive recommendation to the City Council; and

WHEREAS, the aforementioned public hearing was preceded by the posting of public notice in at least three public places within the City limits of Santaquin City, and which notice of public hearing was published in the Payson Chronicle Newspaper on March 18, 2015 in accordance with Section 10-9a-205 of the Utah State Code.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF SANTAQUIN, UTAH, AS FOLLOWS:

Section I.

1. Santaquin City Code, Title 10-7I-2 Permitted Uses is amended to read as follows:

10-7I-2 Permitted Uses

General land uses within the residential commercial zone shall complement the city's general plan for their respective areas. Those uses allowed in the RC Zone are listed in the following matrix. Abbreviations and alphabetic use designations in the matrix have the following meanings:

P	The listed use is a permitted use within the represented area, based on city development standards and ordinances.
С	The listed use requires a conditional use permit within the represented area in addition to complying with all applicable development standards and ordinances.
N	The listed use is only permitted as an accessory use within the represented area.
A	The listed use is a prohibited use within the represented area.

2. S.C.C. §10-7I RC Residential Commercial Zone is further amended as follows:

The following sections of 10-7I are deleted in their entirety and the remaining sections are renumbered accordingly: $\S10-7I-3$, $\S10-7I-4$, 10-7I-5, 10-7I-14, 10-7I-15, 10-7I-16, 10-7I-17, 10-7I-18, and 10-7I-19.

Section II. Contrary Provisions Repealed. Any and all other provisions of the Santaquin City Code that are contrary to the provisions of this Ordinance are hereby repealed.

Section III. Codification, Inclusion in the Code, and Scrivener's Errors. It is the intent of the City Council that the provisions of this ordinance be made part of the Santaquin City Code as adopted, that sections of this ordinance may be re-numbered or re-lettered, and that the word ordinance may be changed to section, chapter, or other such appropriate word or phrase in order to accomplish such intent regardless of whether such inclusion in a code is accomplished. Sections of the ordinance may be re-numbered or re-lettered. Typographical errors which do not affect the intent of this ordinance may be authorized by the City without need of public hearing by its filing a corrected or re-codified copy of the same with the City Recorder.

Section IV. <u>Severability</u>. If any section, phrase, sentence, or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

Section V. Posting and Effective Date. Prior to 5:00 p.m. on, the City Recorder shall: (a) deposit a copy of this ordinance in the official records of the City; and (b) post a copy of this ordinance in three places within the City. This ordinance shall become effective at 5:00 p.m. on June 4, 2015
