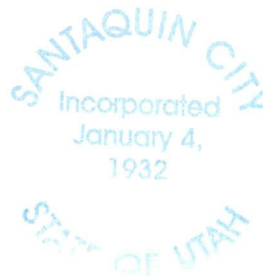

Beginning at the intersection of the northern section line of Sec. 16, T. 8 S., 1 W., SLB&M, and the Utah Lake shoreline; thence southeast and northeast along the Utah Lake shoreline to the western section line of Sec. 10, T. 8 S., 1 E.; thence south along various section lines to the Genola Town boundary; thence south and east along the Genola Town Boundary to the Strawberry Highline Canal; then southeast along the Strawberry Highline Canal to the west section line of Sec. 36, T. 9 S., R. 1 E., thence north along the section line to the northwest corner of Sec. 36, T. 9 S., R. 1 E.; thence east along the section line to the Santaquin City boundary; thence easterly along the Santaquin City boundary to Utah County road 3620 West; thence south along the Santaquin City boundary to the north section line of Sec. 32, T. 9 S., R. 2 E.; thence south along various section lines to the northwest corner of Sec. 21, T. 10 S., R. 2 E.; thence east and south along section lines to the southeast corner of Sec. 21, T. 10 S., R. 2 E.; thence east along the various section lines to the north $\frac{1}{4}$ corner of Sec. 26, T. 10 S., R. 2 E.; thence south to the center corner of Sec. 35, T. 10 S., R. 2 E.; thence west to the $\frac{1}{4}$ corner of Sec. 33, T. 10 S., R. 2 E.; thence south along the eastern section line of Sec. 33, T. 10 S., R. 2 E. to the southern township line of T. 10 S., R. 2 E.; thence west along the township line to the intersection of the southern township line of T. 10 S., R. 2 E. and the Utah/Juab County boundary; thence northwest, southwest and northerly along the Utah/Juab County border to the intersection of the Utah/Juab County border and the south section line of Sec. 9, T. 11 S., R. 2 W.; thence east along section lines to the southeast corner of Sec. 10, T. 11 S., R. 2 W.; thence north along section lines to the northeast corner of Sec. 34, T. 10 S., R. 2 W., thence west along section lines to the north $\frac{1}{4}$ corner of Sec. 34, T. 10 S., R. 2 W.; thence north to Silver Pass Road; thence northeasterly along South Pass Road to the intersection of Silver Pass Road and the south section line of Sec. 11, T. 10 S., R. 2 W., said point being south of Highway 6; thence north through various sections to a point on the south section line of Sec. 26, T. 9 S., R. 2 W., said point being east, approximately 860 feet along the section line, from the southwest corner of Sec. 26, T. 9 S., R. 2 W., such course intersecting with Highway 6 at approximately mile mark 146; thence west along such section line to the south $\frac{1}{4}$ corner of Sec., 27, T. 9 S., R. 2 W.; thence north through various sections to the south $\frac{1}{4}$ corner of Sec. 3, T. 9 S., R. 2 W.; thence west along the section line to the east section line of Sec. 9, T. 9 S., R. 2 W.; thence south along the section line to the east $\frac{1}{4}$ corner of Sec. 9, T. 9 S., R. 2 W.; thence west through various sections to the center corner of Sec. 12, T. 9 S., R. 3 W.; thence south through various sections to the center corner of Sec. 24, T. 9 S., R. 3 W.; thence west through various sections to the center corner of Sec. 23, T. 9 S., R. 3 W.; thence south to the Utah/Juab County border; thence north westerly along the Utah/Juab County border to the intersection of the Utah/Juab/Tooele County boundaries; thence northerly along the Utah/Tooele County border to the intersection of such border with the south township line of T. 7 S., R. 3 W.; thence east along the township line to the southeast corner of Sec. 31, T. 7 S., R. 1 W.; thence south and east along the section lines to the southeast corner of Sec. 32, T. 7 S., R. 1 W.; thence north along the section line to the northwest corner of Sec., 33, T. 7 S., R. 1 W.; thence east along various section lines to the point of intersection with the Utah Lake shoreline and the northern section line of Sec. 35, T. 7 S., R. 1 W.; thence southwesterly along the shoreline to the point of beginning.
