

Beginning at the intersection of the northern section line of Sec. 16, T. 8 S., R. 1 W., SLB&M, and the Utah Lake shoreline; then southeast and northeast along the Utah Lake shoreline to the western section line of Sec. 10, T. 8 S., R. 1 E.; then south along various section lines to the Genola Town boundary; then south and east along the Genola Town Boundary to the Strawberry Highland Canal; then southeast along the Strawberry Highland Canal to the intersection of Interstate 15 and the canal; then due east to western section line of Sec. 33, T. 9 S., R. 2 East; then south along various section lines to the northwest corner of Sec. 21, T. 10 S., R. 2 East to the southeast corner of Sec. 21; then east along the various section lines to the north quarter-corner of Sec. 26, T. 10 S., R. 2 East; then south to the center point of Sec. 35, T. 10 S., R. 2 East; then west to the east quarter-corner of Sec. 33, T. 10 S., R. 2 East; then south along the eastern section line of Sec. 33, T. 10 S., R. 2 East to the southern township line of T. 10 S., R. 2 East; then west along various township lines to the intersection of the southern township line of T. 10 South R. 2 East and the Utah/Juab County boundary; then northwest and southwest along the Utah/Juab County border to the intersection of the Utah/Juab County boundary and the southern section line of Sec. 35, T. 10 S., R. 1 W.; then west along the township line to the southwest corner of Sec. 33, T. 10 S., R. 1 W.; then north along the section line to the intersection of 17600 South and 12800 West; then continue north along 12800 West to the intersection of U.S. Highway 6 and 12800 West (SR 68); then east along U. S. Highway 6 to Mile Marker #150; then due north to a point (east of Mosida) on the northern section line of Sec. 16, T. 8 S., R. 1 W.; then east along the northern section line of Sec. 16, T. 8 S., R. 1 W. to the point of beginning.

Legal Description of Current Juab County Ambulance Service Area:

From the intersection of the Tooele/Utah County line and Sec. 3, T. 8 S., R. 3 W.; south following the Tooele/Utah County line to the Juab County line; west following the Juab/Tooele County line to the Utah/Nevada border; south following the Utah/Nevada border to the Juab/Millard County line; east following the Juab/Millard County line to the Sanpete County line; north following the Juab/Sanpete County line to the Utah County line; west following the Juab/Utah County line to the northwest corner of Sec. 2, T. 11 S., R. 1 W.; west to the northwest corner of S. 4, T. 11 S., R. 1 W.; north on 12800 West to State Road 6; east on State Road 6 to mile marker 150; north to the intersection of State Road 68 and Sec. 4, T. 8 S., R. 1 W.; then west to the intersection of the Tooele/Utah County line and Sec. 3, T. 8 S., R. 3 W. Excluding the service area for Levan Town Ambulance License #1204L which is: I-15 Mile Post 207 Mills Road, west on Mills Road, west on Mills Road to Juab County/Millard County line, then south on Juab County/Millard County line to the southeast Juab County/Millard County/Sanpete County line, then east to the eastern Juab County/Sanpete County line, then north on the Juab County/Sanpete County line to Four Mile Creek, then west to I-15 mile post 207 to the place of beginning.

Beginning at the intersection of the northern section line of Sec. 16, T. 8 S., R. 1 W., SLB&M, and the Utah Lake shoreline; thence southeast and northeast along the Utah Lake shoreline to the western section line of Sec. 10, T. 8 S., R. 1 E.; then south along various section lines to the Genola Town boundary; then south and east along the Genola Town Boundary to the Strawberry Highline Canal; then southeast along the Strawberry Highline Canal to the intersection of Interstate 15 and the canal; then due east to western section line of Sec. 33, T. 9 S., R. 2 East; then south along various section lines to the northwest corner of Sec. 21, T. 10 S., R. 2 East; thence east and south along section lines to the southeast corner of Sec. 21, T. 10 S., R. 2 East; then east along the various section lines to the north quarter-corner of Sec. 26, T. 10 S., R. 2 East; then south to the center point of Sec. 35, T. 10 S., R. 2 East; then west to the east quarter-corner of Sec. 33, T. 10 S., R. 2 East; then south along the eastern section line of Section 33, T. 10 S., R. 2 East to the southern township line of T. 10 S., R. 2 East; then west along various township lines to the intersection of the southern township line of T. 10 South R. 2 East and the Utah/Juab County boundary; then northwest, southwest and northerly along the Utah/Juab County border to the intersection of the Utah/Juab County border and Silver Pass Road, then northeasterly along South Pass Road to the intersection of Silver Pass Road and the south section line of Sec. 11, T. 10 S., R. 2 W., said point being south of Highway 6; thence north through various sections to a point on the south section line of Sec.26, T. 9 S., R. 2 W., said point being east approximately 860 feet along the section line from the southwest corner of Sec.26, T. 9 S., R. 2 W., such course intersecting with Highway 6 at approximately mile marker 146, thence west along such section line to the south quarter corner of Sec.27, T. 9 S., R. 2 W., thence north through various sections to the south easterly 1/16 corner of Sec.3, T. 8 S., R. 2 W.; thence east along the section line to the southeast corner of Sec.1, T. 8 S., R. 2 W.; thence north along the section line to the northeast corner of Sec.1, T. 8 S., R. 2 W.; thence; east along the section line to the southeast corner of Sec.31, T. 7 S., R. 2 W., thence south and east along the section lines to the southeast corner of Sec.32, T. 7 S., R. 2 W., thence north along the section line to the northwest corner of Sec.33, T. 7 S., R. 2 W., thence east along various section lines to the point of intersection with the Utah Lake shoreline and the northern section line of Sec.35, T. 7 S., R. 1 W., thence southwesterly along the shoreline to the point of beginning.

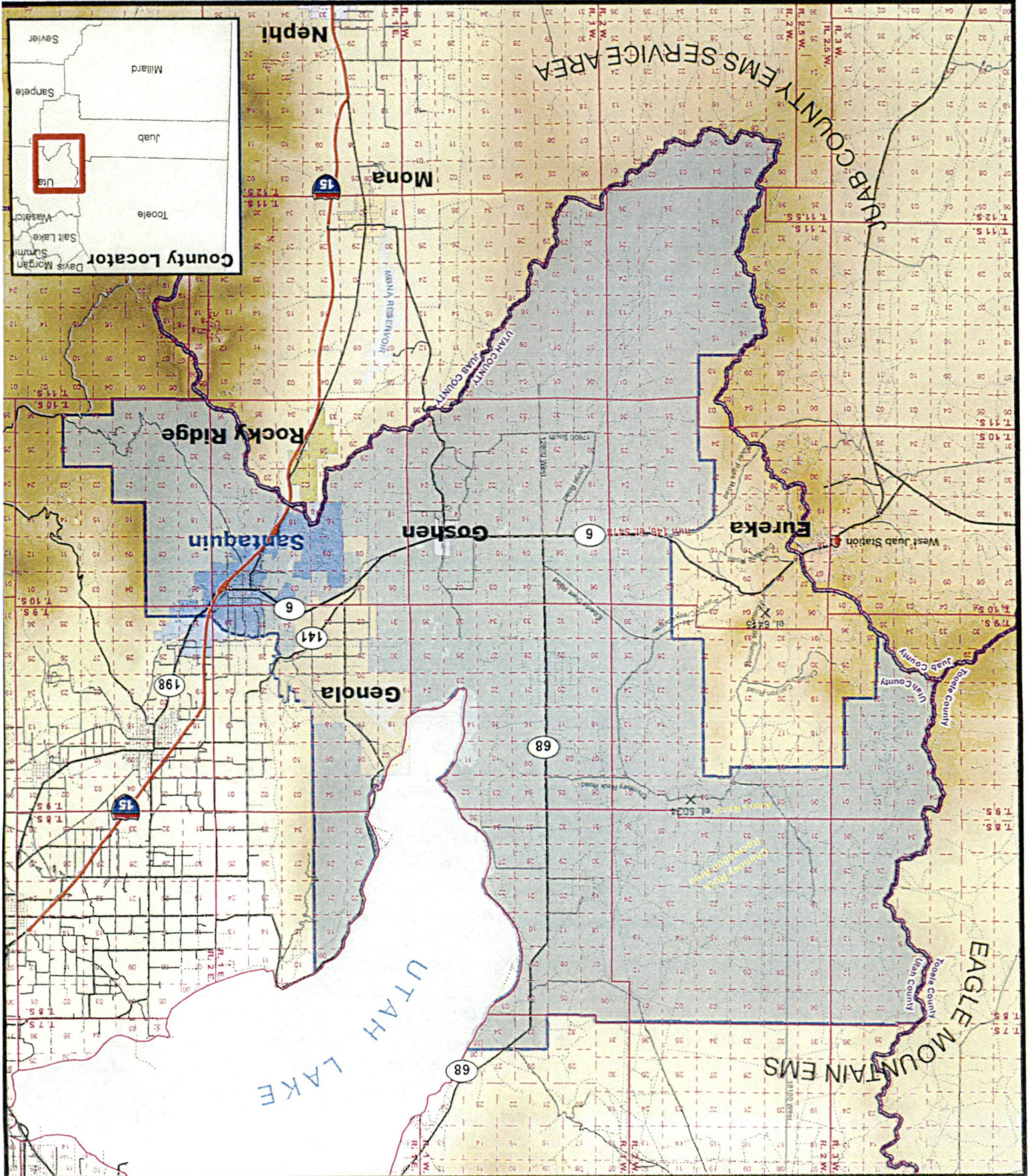
